### **Attention: All Providers - New HCPCS and CPT Codes for COVID-19 Testing**

DMAP expands Healthcare Common Procedure Coding System (HCPCS) codes and adds new Current Procedural Terminology (CPT) codes for COVID-19 testing. Here is a review of the codes:
