

Delaware's EVV Status

- Section 12006 of the 21st Century CURES Act requires all states to implement an EVV system for personal care services and home health services.
- In 2021, Delaware terminated its contract with its initial EVV vendor and delayed EVV implementation until a new vendor was identified.
- Delaware signed a contract with Sandata in December 2021.
- DMMA, Gainwell, and the MCOs have started the system design.
- Sandata's EVV system will go live in December 2022 for personal care services and home health services.


What Providers Can Expect

- No changes to what services will be subject to EVV.
- No changes to Delaware's statewide aggregator EVV model.
- Sandata supports collection of EVV data through a mobile application or telephony.
 - Bring your own device is the preferred method; however, State-issued devices will be available to providers using the Sandata system for EVV data collection who need devices.
- Providers who use alternate EVV systems will submit their EVV data to the Sandata aggregator.
 - Alternate EVV systems will have the opportunity to test visit data transmission prior to golive.
- A survey will be sent from Sandata to providers soon.

What Providers Can Expect

- Sandata user training will be provided via virtual instructor-led training and recorded webinars.
- A soft-launch with a few selected providers will take place prior to go-live.
- Monthly provider forums will be held to share information and answer questions.
