Direct-Entry Midwifery Relationship & Standards Subcommittee Meeting June 4, 2014 6:00-8:00 PM Summary Notes

I. Welcome and Introductions

Dr Tildon-Burton welcomed members and attendees. Since subcommittee members and public attendees were all acquainted with one another – introductions were deemed unnecessary. Co-Chair Janice Tildon-Burton led the meeting with the support of Co-Chair Matthew Heiger.

II. Updates from Members

Legislation

A significant number of members and public attendees had attended the Delaware House Health and Human Development Committee immediately prior to this meeting. There were strong feelings vocalized regarding the positions expressed at the Committee Hearing by persons from agencies and organizations involved in the subcommittee work. This resulted in an extended, and at times, heated discussion. In brief – some thought that agencies and organizations had adequate opportunity for input and that the input had been incorporated in the bill; and therefore they did not understand opposition.

- screening criteria for acceptance for out-of-hospital midwife care
- maternal/fetal/neonatal circumstances requiring collaboration or transfer
- suggestions for improved professional collaboration and support among all birth professionals
- any additional standards recommendation that your organization considers important
