

Delaware Weekly Influenza Report Week 12 (March 16 – March 22, 2014) Delaware Division of Public Health

National Synopsis 2013 - 2014

National data are updated Friday of each week. Please visit http://www.cdc.gov/flu/weekly/ for the most current information. During week12, the decrease of influenza activity continued in the United States. Four states reported widespread activity; seven States and Guam reported regional activity; D.C. and 17 states reported local activity; 22 states and Puerto Rico reported sporadic activity; and the U.S. Virgin Islands did not report influenza activity.

Surrounding states in our region reported sporadic (WV), local (D.C., PA, and MD), and regional (VA) influenza activity.

Both national and state data are provisional and subject to change as additional reports are received.

Delaware Influenza Surveillance 2013 - 2014

There were 62 confirmed cases of influenza reported during week12 and the level of influenza activity was designated "Local" based on available data. The rates of influenza like illness (ILI) reported by sentinel providers was 1.41%, below the regional baseline of 2.0%.

Level of Influenza Activity¹ in Delaware, Week 12

Local

Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed² influenza in a single region of the state.

Influenza-like illness (ILI) is defined as patients presenting with fever of 100° F or greater, cough and/or sore throat in the absence of a known cause other than influenza.

No Activity: No laboratory-confirmed² cases of influenza and no reported increase in the number of cases of ILI.

Sporadic: Small numbers of laboratory-confirmed influenza cases or a single laboratory-confirmed influenza outbreak has been reported, but there is no increase in cases of ILI.

Local: Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed² influenza in a single region of the state.

Regional: This level does not apply to Delaware. Per CDC, regional does not apply to states with ≤ 4 regions³.

Widespread: Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed² influenza in at least half the regions of the state with recent laboratory evidence of influenza in the state.

Activity levels may not be comparable across states because some states may use different definitions for lab confirmation of influenza cases. Some states may include rapid diagnostic tests as confirmatory while Delaware considers viral culture or PCR as confirmatory.

² Laboratory confirmed case= case confirmed by viral culture or PCR.

³ Region= population under surveillance in a defined geographical subdivision of a state. Regions typically include several counties.




Figure 1. Confirmed cases¹ of influenza by type and subtype, Delaware 2013-2014 Influenza Season.

¹ Based on patients with positive nucleic acid or viral culture test results reported to the Delaware Division of Public Health. There were 62 confirmed cases of influenza reported during MMWR 12. Confirmed cases are reported for the date the specimen was collected; not the date that positive test result was reported; this is different from the percent positive calculation.

² Percent positive= (number of specimens PCR positive for flu reported during the week) / (total number of specimens submitted during the week); lab data reflect the date the test result was reported and not the date that the specimen was collected. The percent positive reflects only the percent testing positive for specimens submitted by WHO/NREVSS Collaborating Laboratories in Delaware (includes Christiana Care and the Delaware Public Health Laboratory). The percent positive does not reflect specimens tested by hospitals not participating in the WHO/NERVSS Collaborating Labs in Delaware.



U.S. Outpatient Influenza-like Illness Surveillance Network (ILINet) (Sentinel) Provider Surveillance Network:

An ILINet (sentinel) provider conducts surveillance of influenza-like illness (ILI) in collaboration with the Division of Public Health and the Centers for Disease Control and Prevention (CDC). Data reported by ILINet providers, in combination with other influenza surveillance data, provide a national and statewide picture of influenza activity in the U.S.


Figure 2. Percentage of visits for influenza-like illness (ILI) reported by sentinel healthcare providers participating in the U.S. Outpatient ILI Surveillance Network (ILINet), Delaware 2013-2014.



¹ Ten of 11 sentinel providers reported during Week 12. Data are subject to change as additional reports are received.



NOTE: Data provided do not reflect the total number of individuals who have been infected with the influenza virus in Delaware during the reporting period as a result of the following factors:

- Many people ill with influenza-like symptoms do not seek medical care.
- Many who do seek medical care are not tested for influenza.
- The Delaware Public Health Laboratory (DPHL) is limited by capacity to processing a maximum of 3 specimens per day from each reporting entity.
