

National Influenza Synopsis 2019-2020:

National data are updated Friday of each week. Please visit http://www.cdc.gov/flu/weekly/ for the most current information. Geographic spread of influenza during MMWR Week 49 (December 1- December 7, 2019) was reported as follows:

- *Sporadic Influenza Activity* was reported in the District of Columbia, the U.S. Virgin Islands and one state (Alaska)
- Local Influenza Activity in 12 states (Delaware, Hawaii, Iowa, Kansas, Maine, Missouri, New Hampshire, North Dakota, South Dakota, Vermont, West Virginia and Wyoming)
- *Regional Influenza Activity* was reported in Puerto Rico and 14 states (Arkansas, Colorado, Florida, Illinois, Michigan, Minnesota, Mississippi, Montana, New Jersey, Ohio, Oklahoma, Rhode Island, Utah and Wisconsin)
- *Widespread Influenza Activity* was reported in 23 states (Alabama, Arizona, California, Connecticut, Georgia, Idaho, Indiana, Kentucky, Louisiana, Maryland, Massachusetts, Nebraska, Nevada, New Mexico, New York, North Carolina, Oregon, Pennsylvania, South Carolina, Tennessee, Texas, Virginia and Washington)
- Guam did not report.

Summary of International Influenza Activity:

- In the temperate zone of the northern hemisphere, respiratory illness indicators and influenza activity started to increase in most countries. Influenza activity was elevated across the countries in Western Asia.
- In the Caribbean and Central American countries, influenza activity was low overall, except for Jamaica and Honduras. In tropical South American countries, influenza activity remained low
- In tropical Africa, influenza activity remained elevated in some countries of Western Africa.
- In Southern Asia, influenza activity was low across reporting countries, but continued to increase in Iran (Islamic Republic of).
- In South East Asia, influenza activity continued to be reported in Lao PDR and Viet Nam.
- In the temperate zones of the southern hemisphere, influenza activity returned to inter-seasonal levels.
- Worldwide, seasonal influenza A(H3N2) viruses accounted for the majority of detections.

Delaware Influenza Surveillance 2019-2020:

During MMWR Week 49, there were 65 laboratory-confirmed cases of influenza reported among Delaware Residents. Reports of influenza-like-illness (ILI) received from participating providers, facilities, and institutions in Delaware show ILI is 0.37% compared to Delaware's 2019-2020 baseline of 1.9%. Nationally, 3.2% of visits to a healthcare provider were for ILI, which an increase from last week and is now above the 2019-2020 national baseline of 2.4%. All regions were at or above their baselines

Level of Influenza Activity in Delaware, MMWR Week 49:

Local	Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed
Local	influenza in a single region of the state.

Influenza-like illness (ILI) is defined as patients presenting with fever of 100° F or greater, cough and/or sore throat in the absence of a known cause other than influenza.

CDC Definitions:

No Activity: No laboratory-confirmed cases of influenza and no reported increase in the number of cases of ILI.

Sporadic: Small numbers of laboratory-confirmed influenza cases or a single laboratory-confirmed influenza outbreak has been reported, but there is no increase in cases of ILI.

Local: Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed influenza in a single region of the state.

Regional: Outbreaks of influenza or increases in ILI and recent laboratory-confirmed influenza in at least two but less than half the regions of the state with recent laboratory evidence of influenza in those regions.³

Widespread: Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed influenza in at least half the regions of the state with recent laboratory evidence of influenza in the state.

¹2018-2019 Region 3 (DE, DC, MD, PA, VA and WV) Baseline = 1.9%.

² Laboratory-confirmed case = case confirmed by viral culture or PCR.

³ Region = population under surveillance in a defined geographical subdivision of a state. Regions typically include several counties. Regional does not apply to states with \leq four counties.

Confirmed Cases of Influenza by Type and Subtype/Lineage, Delaware 2019-2020 Influenza Season




Figure 1: During MMWR Week 49 for the 2019-2020 Influenza season, there were 17 confirmed cases of Influenza reported by ILINet providers. Twelve were identified as subtype B/Victoria, one was identified as Flu B, three were identified as Flu A/ H1N1, and one was identified as Flu A/ H3N2. The percent positive for samples tested was 16.03%.

¹Percent Positive represents the amount of specimens that tested positive for influenza out of all samples tested for that MMWR week.

U.S. Outpatient Influenza-Like Illness Surveillance Network (ILINet) Sentinel Providers

An ILINet (sentinel) provider conducts surveillance for influenza-like illness (ILI) in collaboration with the Division of Public Health and the Centers for Disease Control and Prevention (CDC). Data reported by ILINet providers, in combination with other influenza surveillance data, provide a national and statewide picture of influenza activity in the U.S.





Figure 2: Delaware's regional baseline² for healthcare visits relating to ILI symptoms in the 2019-2020 Influenza Season is 1.9% and the national baseline³ is 2.4%. In MMWR Week 49, the amount of ILI related visits reported by sentinel providers decreased from 0.63% to 0.37%.



NOTE: Data provided do not reflect the total number of individuals who have been infected with the influenza virus in Delaware during the reporting period due to the following factors:

- Many people ill with influenza-like symptoms do not seek medical care.
- Many who do seek medical care are not tested for influenza.
- The Delaware Public Health Laboratory is limited by capacity to processing a maximum of three specimens per day from each reporting entity.
