

NOTE: The data provided may not be a true reflection of the total number of people who have been infected with influenza virus (including H1N1) in Delaware primarily due to that fact that:

- Many people ill with influenza-like symptoms do not seek medical care
- Many who do seek medical care are not tested for influenza

** Beginning week 42: DPH reinforced the CDC recommended testing guidelines. This effectively reduced the number of tests performed by medical providers and in turn has resulted in fewer test results being received by DPH. This does not mean that the intensity of infections has declined. ILI data indicates it is in fact increasing.

Level of Activity:

Widespread

Outbreaks of influenza or increases in Influenza-like illness (ILI) and recent laboratory confirmed influenza in at least half the regions of the state.


Influenza-like illness is defined as patients presenting with fever over 100° F, cough and/or sore throat in the absence of a known cause other than influenza.

- **No Activity:** No laboratory-confirmed cases of influenza and no reported increase in the number of ILI.
- **Sporadic:** Small numbers or isolated cases of laboratory-confirmed influenza cases or a single laboratory-confirmed influenza outbreak has been reported, but there is no increase in ILI.
- **Local:** Outbreaks of influenza or increases in ILI and recent laboratory-confirmed influenza cases in a single region of the state.
- **Regional:** Outbreaks of influenza or increases in ILI and recent laboratory confirmed influenza in at least 2 but less than half the regions of the state. (This level of activity does not apply for small states with 4 or fewer regions.)
- **Widespread:** Outbreaks of influenza or increases in ILI and recent laboratory-confirmed influenza cases in at least half the regions of the state.

Sentinel Provider Surveillance Network:

An influenza sentinel provider conducts surveillance for influenza-like illness (ILI) in collaboration with the state health department and the Centers for Disease Control and Prevention. Data reported by sentinel providers, in combination with other influenza surveillance data, provide a national and statewide picture of influenza virus and ILI activity in the U.S.


Influenza-like illness reported from Sentinel Providers-Delaware 2009-2010
18 of 20 Sentinels reporting




Hospital Electronic Surveillance Data-Delaware 2009-2010

5 of 5 Hospitals




Hospital Paper Surveillance Data-Delaware 2009-2010


Influenza-like illness reported from Federally Qualified Health Centers (FQHC)-Delaware


**Influenza-like illness reported from Dover Air Force Base (DAFB)-Delaware 2009-2010
Active Duty & Dependents**




**Influenza-like illness reported from Long-Term Care Facilities (LTC)-Delaware 2009-2010


Influenza-like illness reported from Colleges/Universities-Delaware 2009-2010




