## TRAINING COURSE DESCRIPTIONS

### Approved Sampler/Tester (AST) Training for Non-Operators

An approved sampler/tester is certified by Delaware Health and Social Services to conduct routine water sampling and water quality analyses for Public Water Systems. To be certified as an AST, an individual must attend the AST Basic class and pass a test to receive certification. To renew the AST certification, an individual must take the AST Refresher class and pass the test. The AST trainings do not offer Educational Contact Hours (ECHs).

## CONSUMER CONFIDENCE REPORTING

All Community Water Systems (CWSs) must deliver a Consumer Confidence Report (CCR) by July 1 of each year. This report must be compiled according to the regulations set forth in 16 Del. C. § 4462, § 6.

**Consumer Confidence Reporting** teaches the format and key elements required for a regulatory-compliant CCR.

**Who should attend:** PWS operators and/or any PWS personnel who will be responsible for compiling the CCR on behalf of a Community Water System. Attendance at the course will provide 3 Continuing Education credits.
