Brief Project Narrative

Nephrology Associates, P.A. (NAPA) has operated a Vascular Access Center (VAC) in Newark for 17 years. Currently, the VAC operates as an extension of practice (EOP), licensed by the State of Delaware, and accredited by the Accreditation Association for Ambulatory Health Care (AAAHC). NAPA is the only nephrology practice in the State of Delaware with Interventional Nephrologists specifically trained in management of dialysis vascular access. These services to patients in Delaware are essential for them to receive life-sustaining dialysis treatments.

NAPA plans to convert the VAC to a free-standing Ambulatory Surgery Center (ASC) to continue providing high-quality, efficient, convenient, and cost-effective vascular access services to dialysis patients in Delaware. Severe reductions in payment, starting in 2017 and proposed for 2022; are seriously threatening our ability to maintain operations of the VAC

NAPA is concerned that if we close or reduce services at the VAC patient care will suffer and will have no alternative other than the hospital for these procedures, essentially "turning back the clock" on major progress in efficiency, cost-effectiveness, and quality of care. The sheer volume and immediacy of these procedures cannot be absorbed using existing community resources. If the VAC operations are reduced or closer will inevitably result in delayed care, missed dialysis treatments, and increased morbidity, leading to increased hospital admissions and increased use of catheters for dialysis care. Additionally, care provided in the hospital setting is significantly more expensive than in EOP or ASC settings, potentially adding to the already high cost of caring for End Stage Renal Disease (ESRD) patients. Taking these procedures to the hospitals is directly contrary to CMS initiatives to enhance accountability through a shared-risk payment model, known as "Comprehensive Kidney Care Contracting" (CKCC), which is designed to improve outcomes and reduce the overall cost of care for patients with chronic kidney disease (CKD) and ESRD. NAPA is currently taking steps to participate in this and other shared-risk payment models.
