Updates from Last Meeting

- Use of the CG modifier
 - Informational modifier used to identify claims with procedure codes that are typically subject to EVV to indicate that the service is not subject to EVV per DMMA policy.
 - Reasons a visit is not subject to EVV include:
 - services provided by a paid caregiver who lives with the individual,
 - services provided in a location outside of the home (e.g., school, hospital when an individual is enrolled in the Lifespan waiver)
 - services provided as part of the hospice benefit when the individual is enrolled in hospice
 - services provided to a newborn who does not yet have their own Medicaid ID number
 - services provided out of state.

Updates from Last Meeting

- Visits that span two days (visit starts at 10:00 pm and ends at 6:00 am)
 - These visits will not be required to be broken into two different claim lines. (this is a change from previous instruction given for use with the previous vendor's system)

- Rounding Rules

Rule 1: 15 minute unit of Service

0s - 479s (<8 min)= 0 Units

480s - 1379s (≥ 8 min <23 min)= 1 Units

1380s - 2279s (≥ 23 min <38 min) = 2 Units

Rule 2: 1 hour unit of Service

0s - 479s (<8 min)= 0 Units

480s - 1379s (≥ 8 min <23min)= .25 Unit

1380s - 2279 (≥ 23 min <38min) = .50 Unit

2280s - 3179 (≥ 38 min <53min) = .75 Unit

3180s – 4079(≥ 53 min < 68min) = 1 Unit

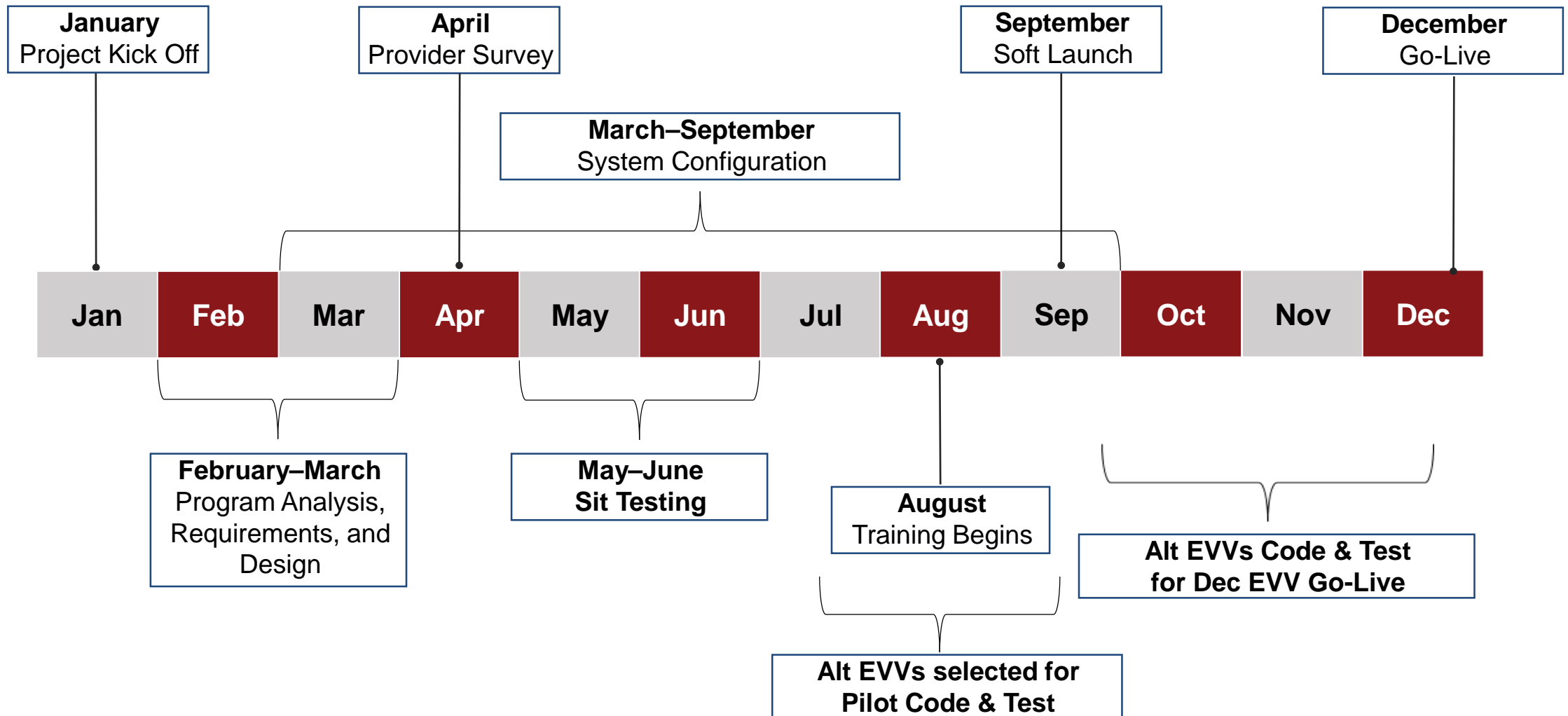
EVV Provider Survey

- Only 1 response per agency please.
- Deadline for completion is 5/27/2022.

Alternate (Alt) EVV Process Overview

- The Alt EVV Delaware Specifications will be shared with vendors during the Provider Forum 5/25/2022.
- After the System Integration Testing (SIT) activities have completed on 7/7/2022, providers selected for Pilot starting 9/23/2022 will complete an online EVV vendor registration form.
 - Providers and vendors will receive confirmation of that registration from Sandata.
 - EVV vendors will receive testing credentials and testing certification check lists from Sandata.
 - EVV vendors of the providers selected for the Pilot can begin testing in July/August 2022.
 - All additional providers will begin registering their vendors after the Pilot activates on 9/23/2022 but cannot send visits until 01/01/2023.
- During this process DMMA and Sandata will host multiple forums to answer questions that providers and vendors may have.
