The State Auditor will attend November's meeting to discuss grant-in-aid.

Would like to create standard guidelines for political campaigning in senior centers and facilities.

Senator Carper held town meetings last week with the Federal Director of Census for community outreach for hard-to-reach populations and to discuss with constituents that the census takers are legitimate. Suggest what can do to get constituents involved in the census. Sheila Grant to share. Make sure they know the credentials to look for and range of questions that will be asked. Suggest public service announcements that educate what will be involved.

Will try to schedule an Advocacy meeting mid-month at Modern Maturity to discuss these items and what to advocate for. Also go to budget hearings.

RO-visiting legislators for coffee – talking about funding for services for our constituents, educating legislators, especially new ones.

KB-Senior Beach Day, dedicated to Eleanor Cain was a great day. Continuing on kitchen project. Working on new Milford Village project. We Care Wellness Program Innovative Practices Program-UD grant to do health screenings on Meals-on-Wheels routes for no cost. Coordinate with medical providers to ensure problems do not increase.

CF-Hump Night created to reach younger populations on Wednesdays during happy hour – 5-7pm. Has YMCA doing classes and have screenings. Will run for three months to see how well it goes. Modern Maturity Center's 50<sup>th</sup> Anniversary Gala this month – 500 people coming. Have an additional \$50,000 sponsor in addition to the original one. On October 12, putting out a special anniversary edition 16 page color story about the Modern Maturity Center (the Sunday before the Gala). Hope to expand adult day services to Saturdays.

SG-Delaware Healthcare-having annual forum at the end of October; on the agenda is Senior Isolation. Stop Rx Greed Campaign where working on lowering drug prices; following bulk purchasing focus group. Volunteer working on guardianship task force.

EH-PEO.org – philanthropic organization. Go to website to see what it is about. They are to help women meet their educational goals. Symposium tomorrow regarding substance abuse, special populations poster contest and discussion, and Nar Can training.

SH-October 15 is White Cane Celebration at Legislative Hall.

JS-Village to Village Conference – 240 villages across the country and Australia. Social isolation - \$6.7 billion spent in this country on this health impact. Beebe Healthcare – transitional health care – another program with social isolation. Advocating to get other Villages started throughout the state.

LOW-Trying to get congregations talking with public health to sponsor nursing training in congregations. New director – Brian Sanders at Ecumenical Council. Sunday ended Peace Week. Council should do something for our seniors next year for those in isolation. Kick off Non-Violent Cities Wilmington.
