Congratulations to our Newly Credentialed Certified Prevention Specialists in Delaware!

This past fall, the Division of Substance Abuse and Mental Health's (DSAMH) Prevention Team worked with the Delaware Certification Board (DCB) and the International Certification & Reciprocity Consortium (IC&RC) on developing the Certified Prevention Specialist (CPS) credential in the state of Delaware. The DCB approved this credential in October of 2010. As with new credentials, the DCB offered a "grandparent period" allowed individuals to apply for this credential without sitting for the IC&RC Prevention Specialist examination. Prevention professionals were eligible to apply for the CPS credential without examination from January 1 – March 31, 2011.

During November – January, DSAMH's Prevention Team coordinated three information sessions facilitated by Mary Jo Mather, the DCB and IC&RC Executive Director. These sessions reviewed the CPS application, as well as reviewed the benefits of obtaining the certification.

Upon review of all the CPS applicants, the State is happy to announce there are now 72 Certified Prevention Specialist's in Delaware.

DSAMH and the Division of Prevention and Behavioral Health Services (DPBHS) Prevention Teams will continue to work towards enhancing and building the prevention workforce in our state to allow more individuals the opportunity to apply for this credential, as well as sustain those who currently hold it.

On Monday, May 2nd and Tuesday, May 3rd, the 2011 Delaware Prevention and Behavioral Health Forum was held at the Sheraton Hotel in Dover. The conference featured 13 workshops and hosted talks by national and local experts from the fields of prevention, early intervention and treatment. Keynote Speakers included the Director of the Substance Abuse and Mental Health Administration (SAMHSA) Center for Substance Abuse Prevention (CSAP), Frances M. Harding and Dr. Richard P. Keeling, M.D., Principal and Senior Executive Consultant for Keeling and Associates, LLC.

Allen "Duffy" Samuels and Dannette Butler received the 2011, "Live the Village Awards" for their outstanding contributions to the field of prevention. Ms. Krysta Pritchett, a sophomore at Sussex Technical High School, received the 2011, "Build the Village Award" for her dedication to improving her community.



Over 500 people registered to attend the two day conference. Each attendee received a certificate with up to nine (9) content hours of education workshops and they took home a free gift provided by the Delaware's B.E.S.T. for Young Children and Their Families (Bringing Evidence-Based System-of-Care and Treatment) B.E.S.T. team.

DEA Drug Take Back Day April 30, 2011

On April 30, 2011, the Drug Enforcement Administration (DEA) coordinated with state and local law enforcement agencies to remove potentially dangerous drugs from our nation's homes in the form of a national take-back day. The Drug Take Back initiative provided an opportunity for the public to surrender expired, unwanted, or unused pharmaceuticals and other medications to law enforcement officers for proper disposal.

Prior to the April 30th, DSAMH disseminated multiple emails promoting the initiative to a prevention distribution list reaching nearly 400 individuals throughout the state. These emails included information about prescription drug abuse, general information about the Take Back initiative, and location information for the take back sites in Delaware's three counties.

This year, the Philadelphia Division of the DEA coordinated the collection and destruction* of more than 12 tons of unused, unwanted, and expired controlled, non-controlled, and over-the counter drugs. Pennsylvania and Delaware combined led the nation with a 294% increase from the first take back in September 2010 (for a total of 24,894.46 lbs or drugs collected). Delaware's 30 registered take back sites collected a total of 4395.39 lbs.

According to the 2009 Substance Abuse and Mental Health Administration's National Survey on Drug Use and Health more than seven million Americans currently abuse prescription drugs. Each day, approximately, 2,500 teens use prescription drugs to get high for the first time according to the Partnership for a Drug Free America. Studies show that a majority of abused prescription drugs are obtained from family and friends, including the home medicine cabinet. This drug take back initiative addresses a vital public safety and public health issue regarding the misuse and abuse of prescription drugs.

Delaware will continue to support the DEA drug take back initiatives.

*In keeping America "green", all the drug/substances collected were incinerated in accordance with state regulations.

Underage Drinking Town Hall Meetings

The Delaware Prevention Network Alliance held its third Town Hall Discussion to Reduce Underage Drinking on Wednesday, June 1, at the Police Athletic League in Hockessin. The guest speaker was Attorney General Beau Biden. This Town Hall meeting also featured the Division of Prevention and Behavioral Health Services underage drinking video for the Step Up campaign, and a panel presentation with representatives from the Division of Alcohol and Tobacco Enforcement and Christiana Care. A parent and youth discussion took place on the impact and consequences of underage drinking.

Attorney General Biden was also the guest speaker at the June 13th Town Hall meeting, at the Claymont Community Center. Previous Town Hall meetings were also held on Tuesday, May 17 at the Latin American Community Center and Tuesday, May 24, at Sussex Central High School. The overall purpose of these Town Hall meetings was to increase awareness of the prevalence and consequences of adults providing alcohol to minors and engage the community in discussing the issue. All of the Town Hall meetings were supported through the federal prevention set-aside of the Substance Abuse Prevention and Treatment Block grant managed by the Division of Prevention and Behavioral Health Services.

4th Annual Teen Summit Hollywood Invades Delaware

On Saturday, **August 6, 2011**, 11:00 AM to 3:00 PM, the Delaware Prevention Network Alliance, a coalition of 10 community organizations statewide that promotes advocacy for prevention by



implementing prevention curricula, providing program guidance and coordinating services and resources for youth and their families, will host the 4th Annual Teen Summit at the Double Tree Hotel in Wilmington, DE as a part of the 2-day series of events known as, "Hollywood Invades Delaware."

The Summit is an opportunity for teens and their families (parents/guardians) to be exposed to current issues facing today's teens. Teens will engage in interactive, open dialogue workshops facilitated by their peers on topics of interest such as underage drinking and prescription drug abuse, dating and relationships, and financial issues. The Summit will provide teens a voice to articulate these issues in their community and with their peers. Teens will learn information that will encourage positive and critical thinking skills and promote self-respect and self-esteem.

DPNA and the Division of Prevention and Behavioral Health Services are currently holding statewide focus groups with teens to gather input on possible discussion topics and celebrity guest. The first was held in Dover on Wednesday, June 1, 2011 at the Greater Dover Community Foundation Building, and the second in Georgetown on Wednesday, June 8, 2011 at the First State Community Action Agency Offices. So far, we have received input from 19 youth in Kent and Sussex Counties. A third focus group will be held with teens in New Castle County on Thursday, June 16, 2011 at the Edgemoor Community Center.
