



SUPERVISED VISITATION AWARENESS MONTH



For over 20 years, **Delaware's Family Visitation Centers** have been providing supervised visitation and monitored exchanges.

The staff at Child, Inc. and Turning Point with People's Place II, Inc. provide a **safe**, structured, and nurturing environment where children can maintain or re-establish a relationship with a non-custodial parent and/or other visiting parties. They help keep children and adult victims **safe** during exchanges and visitation.

Family Visitation Centers are appropriate if: Family Court or the Division of Family Services has determined that use of the Centers are appropriate; a family may be experiencing or have a history of intimate partner violence; or the parents have had a history of hostile or violent arguments during the pickup and return of their children.

Research and practice based evidence suggest a variety of tools to increase **safety** of families using visitation centers. **Safety measures** that exist in the Delaware centers include:

- * Separate and distinct entrances and parking areas for each parent;
- * Staggered arrival and departure times;
- * Security camera monitoring;
- * Experienced security guards; and
- * Professionally trained staff
